Making elections accessible for people with disabilities



Before the onset of the general elections 2019, Sightsavers India has been working towards the government's efforts on 'Accessible Elections'. Sightsavers India is playing a pivotal role in this initiative to ensure people with disability are not left behind to exercise their voting rights.

Through this initiative, Sightsavers India is encouraging more voters and empowering DPO members (Disabled People's Organisation) all the more. Keeping this in mind, the DPO members started finding eligible voters who are PwDs in their districts. Sightsavers and its partner organizations in the states of Madhya Pradesh, Uttar Pradesh, Chhattisgarh, Rajasthan, Jharkhand and Odisha liaised with Booth Level Officers at district level which further empowered DPO members to identify PwD's above the age of 18 years and got their voting cards made, making PwDs part of the voting list.

Inclusive Education

Sightsavers successfully renewed its MoU in Madhya Pradesh to provide technical support to the state government and thus strengthen the Inclusive Education system in the state. A Gleaming Vision

65-year-old Shobha is a daily wage labourer and lives with her son in Alipurduar, West Bengal. Thrice a week, Shobha would walk up the hill to collect dry leaves and branches that were used as fuel.

Shobha was diagnosed with cataract in the eye screening camp organised by Sightsavers in her village under the Rural Eye Health Programme. She was referred to the base hospital and was operated for the cataract-removal surgery. "Cataract had really affected me in many ways. I could not even do my day-to-day work before the surgery. However, since I can see clearly now, I wait to go back to my normal life," says Shobha.
