


Sightsavers is a global development organisation that has been working in India since 1966 to eliminate avoidable blindness and to ensure that people who are irreversibly blind are supported adequately to lead lives of independence and dignity. Over the past five decades, Sightsavers has reached out to over 55 million people with potential eye problems till date.

As of now, we work in 100 districts across 8 states of India bringing eye healthcare, educational support, counselling, training and leadership development to visually impaired people in some of the least served areas of the country.

We work in a sustainable way to promote lasting change by strengthening existing health systems, seeking to advocate with and influence governments and by demonstrating best practices. We network with like-minded organisations to enable exchange of ideas and to advocate for the rights of the disabled. Sightsavers believes in promoting technologies in eye healthcare enabling a wider reach of health services in India.

Major Highlights

of the Year

- **01** One of our biggest achievements in the year gone by was the successfull partnership with state governments. It was after signing a MoU with District Health Society of Kanker in Chhattisgarh for Rural Eye Health that Sightsavers is working with government support in all its eight core states of operation.
- **02** In August, Sightsavers India culminated its five year-long **Sundarbans Eye Health Project.** The five years of intervention has resulted in reducing blindness to 0.7 % where the prevalence was 1.9% in 2013-14.
- **03** Sightsavers presented and moderated a number of papers in the **Vision 2020 Annual Meet** in Guwahati in June. At the conference, the district models with government in India that are adopted by Sightsavers was appreciated by all, especially the government officials of other states.
- **04** National Trucker's Eye Health Programme RAAHI completed a year in October 2018. We have been successful in expanding the programme with RAAHI's presence in 33 locations across India. Our honorary brand ambassador **Sri Kabir Bedi** himself visited one of the RAAHI locations in Mumbai in December of 2018 and encouraged many truck drivers to get their vision corrected and spread a word on the same.
- **05** Sightsavers India bagged the prominent ICC Social Impact Award in the large project category for their Sundarbans Eye Health Service Strengthening Project.
- **06** Sightsavers garnered great visibility for its work in the media—electronic, print and digital—in 2018. One of the biggest breakthrough was a partnership with NDTV for their Mission Vision Campaign with Nova eyewear.

MESSAGE FROM THE **CHAIRMAN**

This year, we have also seen a rise in media coverage be it print, digital or broadcast. Our collaboration with NDTV 24X7 was quite well with not only the media giant giving Sightsavers and its many employees coverage on our programmes but also lending support for our urban eye health initiative.

A lot has been planned and a lot has been executed this year. I am very happy to share that Sightsavers and partners have helped to halve blindness cases in remote Indian Sundarbans. These changes prove a positive motion which we continue to practice and achieve as an organisation.

to Inclusion

This one year has been an ascending journey for Sightsavers as an organisation. One of our biggest achievements in the year gone by was to successfully enter partnerships with state governments. It was after signing a MoU with District Health Society of Kanker district in Chhattisgarh for Rural Eye Health that Sightsavers is working with government support in all its eight core states of operation.

In August, we culminated five year-long Sundarbans Eye Health Project. The intervention has resulted in reducing blindness to 0.7% where the prevalence was 1.9%, during the baseline survey. The project was financially supported by Standard Chartered Bank under the 'Seeing is Believing' initiative. Along with this, Sightsavers India also observed a huge change in perceptions due to constant awareness generation in field. About 23,55,720 people were reached through various IECs and community sensitisation activities. It included working with local communities and undertaking sensitisation activities and outreach camps through clubs, women's groups and others.

Our National Trucker's Eye Health Programme – RAAHI completed a year in October 2018. We have been successful in expanding the programme with RAAHI's presence in 33 locations across India. The Cholamandalam grant for the project is another significant win. Going forward we will be expanding the programme to many more locations in the North-South and East-West corridor.

In fundraising, both corporate and individual fundraising teams have done well to achieve overall income targets for 2018. Sightsavers is always grateful for the support it receives from corporates and individual donors alike. The contribution of individuals makes a huge impact in letting us work towards the causes we support.

Sightsavers looks forward to continuously work in tandem with the government, our partners, donors and NGOs towards eliminating avoidable blindness and creating equality of opportunities for people with disability.



The objective of Rural Eye Health Programme is 'improving Vision-related Quality of Life through strengthened eye health systems' with a focus on poor and deprived sections of the society. The year witnessed systems strengthening, service delivery, multi-level advocacy, partnerships development and evidence generation. With Netra Vasant, we seek to increase the Cataract Surgical Rate (CSR) in the selected districts in order to contribute to a reduction in the prevalence of blindness.

Key Highlights

- In Madhya Pradesh, primary eye care centre was established in district Katni supported by Fullerton India Credit Company Ltd. Around three lakh people are likely to access the primary eye cares services from this centre at a location where there are no eye care facilities available.
- Two Sub divisional Hospitals (in Alipurduar and Bankura) have started cataract surgeries with the equipment support from Sightsavers.
- In Bihar, we have successfully been able to increase surgeries in rural district hospitals. From six we have scaled up surgery performance to 21 district hospitals.
- In Rajasthan, as a result of consistent advocacy with the government, GoR has deployed four optometrist in district Chittaurgarh. Earlier there were no optometrists in the district.



A Gleaming Vision

65-year-old Shobha is a daily wage labourer and lives with her son in Alipurduar, West Bengal. Thrice a week, Shobha would walk up the hill to collect dry leaves and branches that were used as fuel.

Shobha was diagnosed with cataract in the eye screening camp organised by Sightsavers in her village under the Rural Eye Health Programme. She was referred to the base hospital and was operated for the cataract-removal surgery.



"Cataract had really affected me in many ways. I could not even do my day-to-day work before the surgery. However, since I can see clearly now, I wait to go back to my normal life."





Amrita Drishti - Urban Eye Health Programme (UEHP) focuses on eye health of urban poor living in slums and aims at establishing system of primary eye care through community resource building and strengthening National Health Mission (NHM).

Key Highlights

- Partnership with State Blindness Control of Programme (SBCP) in Madhya Pradesh resulted in building capacities of 96 ophthalmic personnel on refraction and retinoscopy. Around 45 ophthalmic assistants were provided retinoscope by Sightsavers.
- INR 151 million has been provisioned for ophthalmic equipment in State Programme Implementation Plan (PIP) for 2018-19 in all Government facility at district and sub district level in Madhya Pradesh.
- An eye screening project exclusively for Construction Workers has been launched in Mumbai with support from Urvi Ashok Piramal Foundation.

- All 12 Vision Centres in 12 UPHCs of Patna districts are being run in locations provided by Patna Municipal Corporation.
- Government of Odisha has adopted Sightsavers 'DEHAT' tool (Situational analysis and system assessment tool) for identifying the gaps/ opportunities for planning its Universal Eye Health Programme.
- After constant advocacy, a VC within an Urban Primary Health Centre (UPHC) has been established in the largest red light area of Asia, Kolkata-Sonagachi.
- Government of Odisha started two courses; one for the training of ophthalmic assistants and another for ophthalmic clinical assistants in the ophthalmic sector.



Second Sight

70-year-old Shyam Sundar Devi from Patna had been struggling to see clearly for a year. She had blurred vision in both eyes. As days passed by, Sundar Devi struggled to do her daily chores.

Sightsavers in association with its partner hospital, Sri Sai Lions Netralaya (SSLN) would organise household screenings where a health worker was assigned to perform door-to-door screening in the urban slums. Indu Bala, a health worker did the screening for Sundar Devi after which she was referred to SSLN Hospital for further screening. Sundar Devi was found to have cataract in both eyes and she was operated for it thereafter.

With the gradual improvement in her vision, Sundar Devi has rekindled her love for sewing.



"Had it not been for Indu (Health Worker), I would have never stepped out of the house to get my eyes checked. I'm glad that I had my cataract operated."





Vidya Jyoti - National School Eye Health programme aims to screen children in Government school to identify and prevent eye diseases and vision impairments among children that affect learning outcomes.

Key Highlights

- Sightsavers participated in National BALRANG Mahotsava 2018 - a joint programme of Indira Gandhi Rashtriya Manay Sangrahalaya and Directorate of **Public Instructions, School Education** Department, Madhya Pradesh to promote the artistic talent of the students from 29 states and 5 Union Territories of the country. A stall was placed by the School Eye Health team exhibiting various eye care materials with theme- 'Samarth Bharat-Swastha Bharat'. The attraction of the stall was eye care games such as snakes & ladder, conversation maps, eye health quiz contest, eye screening by young girls -eye care champions (trained students from schools), selfie eye points, take away materials, FAQs on eye care and attractive prizes. Around 3,500 students got their eyes screened.
- Completed primary screening of more than 6 lakh children studying in government schools of Patna District; expanded screening services in private schools of Patna city.
- Department of H&FW, Govt. of Odisha has also adopted primary eye screening kits for the local health workers and school teachers developed by Sightsavers as part of its programme scale up.



Learning and Leading

11-year-old Lakhan attends a government school in Bhopal, Madhya Pradesh. Lakhan had cataract in both eyes since birth. Due to this, he would often face difficulty in his studies. Lakhan underwent an eye screening camp organised by his teachers who were trained as a part of the strategy under Sightsavers' School Eye Health Programme. He was referred to Sightsavers' partner Sewa Sadan Eye Hospital after being identified having abnormal vision. Lakhan was further referred to the base hospital for cataract operation.

After being operated in both eyes, Lakhan's vision has improved tremendously. He is now able to concentrate on his studies better and is doing the daily tasks with ease.



"Thanks to Sightsavers for making my son's life brighter," says Lakhan's father.



RAAHI National Truckers Eye Health Programme

The programme has geographically evolved with 30 locations operational currently falling on and around the Golden Quadrilateral route in India. In a span of one year and by the end of 2018, 11 Static Centres were introduced under the RAAHI programme, with one each in 4 metropolitan cities - Delhi, Mumbai, Chennai and Kolkata. These static centres function as nodal points located mostly in Transport Areas with the provision of eye screening, refraction and referrals. There is also dispensing of spectacles to those identified with refractive error.

The programme received global attention when delegates from Conrad N. Hilton Foundation, The New York Times and Sightsavers International Global CEO-Dr. Caroline Harper visited Delhi to see The National Truckers Eye Health Programme in 2018.

Under the programme, eye screening of BEST Drivers was (Mumbai) done in October 2018. During this short campaign duration (completed in 12 days) 4,823 BEST drivers & conductors were screened and 2,584 were provided with spectacles. This was supported by RPG Foundation under their Netranjali initiative.

During 2018, 51 % of the targeted population were identified with Refractive error problem. Total referrals were 5,463 and of these 1,997 were identified with cataract.

Blindness Halved in Sundarbans

Existing cases of blindness in the Sundarbans, one of India's poorest and most inaccessible regions, have halved in the past five years thanks in part to the work of Sightsavers and its partners.

Sightsavers along with Standard Chartered Bank initiated the Sundarbans Eye Health Service Strengthening Project in 2013. The project aimed to address the urgent need for improving eye health in selected blocks in North 24 Parganas and South 24 Parganas (West Bengal, India). The project was financially supported by Standard Chartered Bank under the 'Seeing is Believing' initiative. The five years intervention has resulted in reducing blindness to 0.7 % where the prevalence was 1.9%, during the baseline survey in 2013-14.



INCLUSIVE EDUCATION

The Inclusive Education Programme is implemented in five states. The programme prioritises technical support to Sarva Shiksha Abhiyan (SSA) for training and capacity building of general teachers to address education needs of the Children with Disabilities (CWDs) with special focus on children with visual impairment. The programme aims to demonstrate scalable approaches to strengthen systems and build a cogent institutional response. The thematic focus of the programme is to expedite quality of learning outcomes for the CWDs and secure enablement through teacher training, ICT promotion, technical, infrastructural and community support.



- The Government of Odisha has formed a task force under the guidance of Sightsavers for developing strategies and classroom transaction modules, which are inclusive to all students including the visually impaired.
- Sightsavers provided printable format of all books Class I to Class-VIII to the Education Department and initiated printing of braille books in the Government Braille Press, in Bihar. There is increased budgetary allocation to Inclusive Education component of Sarva Shiksha Abhiyan (SSA) Programme for Bihar with Sightsavers efforts.
- In Rajasthan, INR 10.5 million has been provisioned towards procurement of devices for children with visual impairment (CVIs) by Samagra Shiksha Abhiyan, Department of Education GoR.
- O Several activities were undertaken with the government of Madhya Pradesh to enable quality learning outcomes among children (i) Beginner and advanced trainings organised on using smart phones for 44 children with visual impairment (CVIs) to enhance ICT skills and enable learning outcomes among them; (ii) Trained 47 teachers on inclusive teaching practices and computer based learning; (iii) Trained 58 members of school management committees (SMC) on regularisation of children with disabilities; and (iv) Collaborated with Composite Regional Centre (CRC) under Department of Social Justice to provide technical support and train 68 children on operating smartphones.
- Jharkhand Education Project Council, Government of Jharkhand has provided space for establishment of resource centre at Ranchi, Dumka and Hazaribag. All the textbooks in Jharkhand can be converted into accessible format and persons with disabilities can easily access the content. The Government of Jharkhand has accepted the same and is ready to provide it to all the schools through tabs.





The Girl with an Inquisitive Sight

11-year-old Vibha studies in a government school for economically weaker sections in Jehanabad, Bihar. Vibha is visually impaired since birth and is supported by Sightsavers under its Inclusive Education Programme. Vibha has been trained and provided with accessible devices which assist her in studies.

After signing the MoU with the Government of Bihar, Sightsavers is allocating all kinds of accessible devices required by children with visual impairment for educational, recreational and mobility purposes in the government schools of the state.

As far as first impressions go, Vibha comes across as shy and an introvert. But when faced with a mathematical challenge, her shyness quickly evaporates. While she might be just another 11-year-old going through the rigmaroles of middle school, her teachers feel that Vibha has mathematical aptitude way beyond her years.



"I wonder how people don't like Maths. I see myself teaching in big universities when I grow up."





Key Highlights

- In West Bengal, a training manual on Inclusion in SHG for District Level Trainers has been developed by Sightsavers and has been adopted by the Panchayat and Rural Development Department.
- In Bihar, 589 DPGs were formed and 114 DPGs have opened their bank accounts.
- In a major advocacy success, government has agreed to scale up the leadership development model taken by Sightsavers in its demonstration districts in every Panchayat (Local Governance unit) level to usher the social inclusion and integration process at the village level.
- As a result of advocacy, 15 SHGs linked with livelihood intervention in different trades and loan of INR 7, 50,000 received from NABARD for seven SHGs for livelihoods and enterprise expansion in Madhya Pradesh.
- To promote accessible and inclusive elections in Madhya Pradesh, Rajasthan and Chhattisgarh in 2018, PWD and DPO members jointly collaborated in different activities with the Election Commission.
 - (i) In Madhya Pradesh, workshops were held with district election department where 45 PWDs learnt to use EVM and VVPAT machines. The Election Commission of district Hoshangabad created 1,600 accessible voting booths. (ii) Similarly in Rajasthan, DPO members were engaged in Systematic Voters Education and Electoral Participation (SVEEP) campaign focusing on inclusive elections.

- (iv) In Uttar Pradesh, DPO members formed a district election committee.
 (v) In Chhattisgarh, Sightsavers' partner organised the training of election officers on formulating strategies to make assembly election inclusive for persons with disabilities.
- In Madhya Pradesh, three women from a DPO supported by Sightsavers became members of committee monitoring violence against women formed by department of Police.
- Thirty visually impaired girls from Madhya Pradesh were trained on self-defence and life-skills.
- Sightsavers has been nominated as technical partner for State Planning Commission in MP to provide support on SDG implementation and monitoring specifically on disability.
- In Madhya Pradesh, 966 PWDs were mobilised to get registered in Unique Disability Identity Card (UDID) scheme in collaboration with District Disability Rehabilitation Centre (DDRC).
- State level orientation on implementation of European Union supported project 'Building Partnership for Sustainable Development Goals Empowering Disabled People's Organisation' held in Madhya Pradesh and Chhattisgarh for members of DPO and project staff.
- Delegates from Sightsavers India and representatives of Disabled People's Organisations (DPOs) supported by Sightsavers were invited for the European Disability and Development week in Brussels.





Inclusion Matters

30-year-old Sangeeta is a voter from Chittaurgarh, Rajasthan. She has orthopedic disability and is a member of Mewar Viklang Sewa Sansthan since 2010- DPO supported by Sightsavers in assocation with CUTS International. As soon as Sangeeta became a DPO member, there was no looking back for her. Since then she has been actively involved in representing the organisations in front of national and international representatives. She along with other DPO members actively participated in making 2018 Legislative Assembly Elections inclusive for persons with disabilities in Rajasthan.

Sangeeta also has a degree in Master of Arts in Education. She is currently planning to apply for teaching in government school.



"Voting should be an integral part of everyone's life. Due to the provision of suitable facilities for persons with disabilities at the polling stations, we saw a major turn out of voters with disabilities here in Chittaurgarh. This is certainly going to create a very positive end-result for the entire country."





The year 2018 began on a high note for the Funding & Marketing division. Sightsavers bagged the prestigious HCL Grant 2018 for Education from Home Minister Sri Rajnath Singh, contesting more than 3,000 NGOs in India. The department overachieved its overall income targets at 109 percent. We have been expanding into new geographies like Chennai and Kolkata with face-to-face fundraising doing remarkably well. At the same time we are revisiting our strategy for in-house tele calling process with the changing markets.

The year was big on visibility in the media for Sightsavers India. We made our presence felt in broadcast, print and digital media across the country covering our programmes, events, and key profiles from within Sightsavers India. NDTV 24&7, The Hindustan Times, The Indian Express, Business Today, The Sunday Guardian, Wires like PTI, India Today digital were few amongst the many news platforms where we garnered coverage.

सुंदरवन क्षेत्र में दृष्टिहीनता को हटाने के लिए पहल

सहदसेवर्स इंडिया, अग्रणी अंतरराष्ट्रीय विकास संगठन ने स्टैंडर्ड चार्टर्ड बैंक के साथ सुंदरवन में पांच वर्ष तक चले सुंदरवन आई हेल्थ प्रोजेक्ट का समापन किया। इस रिपोर्ट में सुंदरवन में आई हेल्थ प्रोजेक्ट की पांच साल की प्रगति बताई गई। इस प्रोजेक्ट का उदेश्य 2018 तक पश्चिम बंगाल के मुंदरवन क्षेत्र में टालने बोग्य अंधरव को इटाने में बोगदान देना था। इस प्रोजेक्ट के साथ साइटसेवर्स ने क्षेत्र में आंखों से संबंधित किपायती स्वास्थ्य सेवाओं को मुघारने और पहुंच बढ़ाने का उद्देश्य तय किया था। साइटसेवर्स इंडिया ने 2013 में 'सुंदरवन आइ हेल्थ सर्विस स्ट्रेंथेनिंग प्रोजेक्ट' की फाल की थी। इस प्रोजेक्ट का उद्देश्य उत्तर 24 परगना और दक्षिण 24 परगना (पश्चिम वंगाल, भारत) के चयनित ब्लॉक में आंखों के स्वास्थ्य को मुधारने की तत्काल जरूरत को पूरा करना था। स्टैंडर्ड चार्टर्ड ने 'सीइंग इस विलिचिंन' फल के अंतर्गत इस प्रोजेक्ट को वितीय सहयोग दिया था। पांच साल के प्रवास का नतीजा वह रहा कि बेसलाइन सर्वे के दौरान दृष्टिहीनता पहले के 1.9 फीसद के फैलाव से कम होकर 0.7 फीसद पर पहुंच गई। आरएन बोहंती, मुख्य कार्यकारी अधिकारी, साइटसेवर्स इंडिया ने कहा कि साइटसेवर्स इंडिया ने क्षेत्र में लगातार जागरुकता फैलाने से समझ को निर्णायक भूमिका निर्भाई।






Income FY 18-19
