

Sightsavers India and Standard Chartered Bank join hands to create a safe and accessible environment for eye health facilities amidst Covid-19.

Sightsavers and Standard Chartered Bank announced their collaboration on promoting safe working environment in several hospitals and community eye health centres amidst COVID-19 crisis. In the current times, it is essential for hospitals to create and maintain safe working environment for its staff as well the patients while providing other essential non COVID-19 services.

The project intends to provide material support to the partner hospitals in Kolkata, Sunderbans and Mumbai. In particular, support will be given to the clinical partners and vision centres which have been supported by Standard Chartered Bank under Sightsavers 'Rural and Urban Eye Health Programmes' in the state of West Bengal and Maharashtra.

The initiative will help in improved access to personal protective equipment's among the health professionals and the patients in the identified districts and also reduce vulnerabilities of local communities, enabling them to better prepare for, mitigate and respond to COVID-19 disaster.

#### Nomesh's Story - Serving the needy amidst Covid-19

Nomesh hails from Raipur district in Chhattisgarh, India. He has orthopaedic disability.

In 2019, Nomesh became involved with a disabled people's organisation (DPO) which was supported by Sightsavers under the Social Inclusion Programme. In 2019, Nomesh was unanimously elected as president of the same DPO.

During the COVID-19 pandemic outbreak and subsequent lockdown, Nomesh assisted the District Social Welfare Department in identifying families in need amidst the pandemic. With the support of other DPO members, Nomesh prepared a list of 68 families with disabilities who had been severely affected due to lockdown. He shared the list with the department and followed up until the identified families received the support that they needed.

Nomesh stitched around 350 masks and distributed them to policemen, health workers and daily wage workers. He also distributed food packets to around 56 migrant families. Adding to these, he volunteered and delivered medicines to 20 sickle cell patients, amidst the lockdown. Due to his dedication to help others, Nomesh became a source of motivation for many DPO members. He says that his efforts to help people out makes him happy.

"If nothing else, this is my small contribution for the people of my country," says Nomesh.
