



#### From Tragedy to Triumph: Shera's Journey to Empowerment

Shera is a 34-year-old resident of Unnao, Uttar Pradesh. About five years ago, his life took a tragic turn when he fell from a train and lost both his legs.

With the help of the village head, he obtained a disability certificate and began

## **Empowering Students with Visual Impairment: Distribution of Laptops**

Under the Inclusive Education Programme, STARs project, the Odisha School Education Programme Authority (OSEPA) has successfully distributed **343 laptops** across 27 state districts, enhancing educational opportunities for visually impaired students.

At the State-level programme, **80 laptops** sourced from the Khurda district were allocated to students with visual impairments. This initiative underscores the commitment of stakeholders to fostering accessibility and equitable educational resources for all learners.

#### Job Fair Success: Over 60 Candidates Shortlisted

In collaboration with the Department of Social Security & Empowerment of Persons with Disabilities Department (SSEPD), Govt. of Odisha, and National Career Service Centers for Differently Abled (NCSCDA), Sightsavers India organised an exclusive job fair in Pokhariput, Bhubaneswar, to empower individuals with disabilities. Of 117 participants, over 60 candidates were shortlisted by multiple companies for the final rounds of interviews.
