# Our journey of 50 years and counting

Launched our first national programme, The Xeropthalmia Programme to tackle nutritional blindness. Sightsavers India was one of the first eye-care organisations to respond to the 1984 Bhopal Gas tragedy by establishing eye-care hospitals and providing relief supplies. 0----

Sightsavers India started its operations in 1966. Established a robust outreach programme providing mobile eye care vans and equipment support to hospital-based in Tamil Nadu and Uttar Pradesh.

Registered in 1970 and launched the Eyes of India Campaign, which restored sight for more than 400,000 people. Sightsavers India supported setting up the first permanent base hospitals to provide low-cost mass treatment.

# 2000s

Became one of the founding members of Vision 2020 India -The Right to Sight. Scaled up our work to 14 states and pioneered the integrated education IEDC, subsumed in 2009 with Sarva Shiksha Abhiyaan as Inclusive Education.

Partnered with various eye care centres to make high-quality cataract surgery affordable, advocated the shift from surgical camps to preventive diagnostic camps, and initiated comprehensive eye care services.

## **2010s**

We strengthened accessibility with voice-enabled, braille banking services and developed strategic partnerships with State Governments. We were instrumental in making amendments to the India Copyright Act to enable information to be converted into an accessible format.



#### Netra Vasant - The Rural Eye Health Programme

A large population of our country still resides in villages. Netra Vasant aims at improving vision-related quality of life through strengthened eye health systems in rural areas of India. The programme aims to achieve universal coverage vis-a-vis eye health services in rural communities by reducing blindness prevalence, providing equitable coverage, and financial & programmatic sustainability.

Sightsavers India Fellowship Program through training of eye care professionals and encouraging them to work in rural areas aims at ensuring equitable and impactful eye healthcare services across the most underserved parts of the country.



#### Amrita Drishti - The Urban Eye Health Programme

We work in metropolitan cities to ensure comprehensive and sustainable eye health mechanisms for the urban slums of India. The programme improves urban eye care for low-income residents in 16 cities by building community resources and strengthening the National Health Mission. Amrita Drishti integrates its vision centres with the government's Urban Primary Health Centres (UPHCs).

In addition to providing direct services, this enables Sightsavers India to ease disadvantaged beneficiaries into the public health system through strengthened referral mechanisms, especially for cataracts. The Programme makes available healthcare Mobile Vans that offer various services – Teleconsultation, Glaucoma and Diabetic Retinopathy screening, Portable perimetry, Ready to Clip (R2C) glasses and spectacle sale.





#### Vidyajyoti - National School Eye Health Programme

Sightsavers India launched Vidyajyoti School Eye Health Programme with the goal that 'good and maintained eye health' is optimized in school children, so the improved learning outcomes in schools are evident. Vidyajyoti has achieved a historic scale by reaching out to more than 3.5 million students enrolled in government schools in the intervention districts while providing free spectacles to 50,000 children.

Under the programme, we provide eye health services for students of rural districts attending government, non-government semi-aided private schools in the age group 5-18 (up to class-12), improving learning outcomes and enabling early detection.








#### **RAAHI - National Truckers Eye Health Programme**

One of India's most extensive eye health programmes, RAAHI, focuses on ensuring road safety by providing eye care services to the truckers' community. The programme is spread across 54 locations across the golden quadrilateral and North South-East West (NSEW) network. The Programme is designed so that eye care services reach overworked truck drivers and commercial drivers at their convenience. We have permanent vision centres and pop-up outreach camps in locations where drivers stop as part of their usual route to rest or unload cargo.


The use of fully equipped mobile ophthalmology van under the programme makes eye health more accessible for the commercial driving community.

### **Inclusive Education Programme**

Sightsavers India aims to promote a positive and enabling environment in schools, families as well as communities to support the holistic education of children with visual impairment. Enablement is facilitated by availability of assistive devices and accessible educational material, provision of compensatory skills training, infrastructure accessibility and building education management and leadership among others.

Under the Inclusive Education Programme, we ensure that children who are blind or visually impaired are included in mainstream education. This is crucial to lifting people out of poverty.



## **Social Inclusion Programme**

We work to equip people with disabilities with the skills (daily living, vocational training, etc.), tools and assistance they need to earn a living and lead an independent life. To enable the Social Inclusion of people with disabilities, we focus on three core areas: Institution Building, Economic Empowerment, and Enabling Environment. Sightsavers India advocates for all 21 disabilities as outlined under the RPwD Act 2016, with a focus on the eight prominent disabilities. With a comprehensive approach to gender, we also provide adolescent girls with self-defense training and health and hygiene sessions.





## Sightsavers India Fellowship Programme

Sightsavers India is committed to grooming young ophthalmologists into promising and skilled professionals. The Fellowship, an innovative course of mentoring and surgical exposure, is designed to give an opportunity to master the craft of a clinician and a surgeon and expand their perspectives on rural eye health.

Sightsavers India's Fellowship is a promising career opportunity for ophthalmologists. It aims to take selected fellows through an exciting journey of 24 months.

The fellows experience a structured skill enhancement and mentoring process covering not only clinical and surgical ophthalmology but also managerial and holistic life skills. After a rapid four-month training on SICS, the fellows are placed in the peripheral centres of one of the 8 states – Madhya Pradesh, Uttar Pradesh, Bihar, Jharkhand, West Bengal, Rajasthan, Chhattisgarh, and Odisha. The process involves skills up-gradation components and personal interactions with eminent leaders in the eye care and development sector.









## Government Relations & Policy Engagement (GRAPE)



The Government Relations & Policy Engagement (GRAPE) Unit is responsible for building strong external relationships and networks to advance Sightsavers India's initiative against avoidable blindness and to promote equality of opportunity amongst people with disabilities.

The GRAPE unit works to strengthen Government relations and develop strategic alliances, networks, partnerships, and circles of influence to positively impact people-centred policy changes in eye healthcare, disability-inclusive development, and inclusive education in India.
