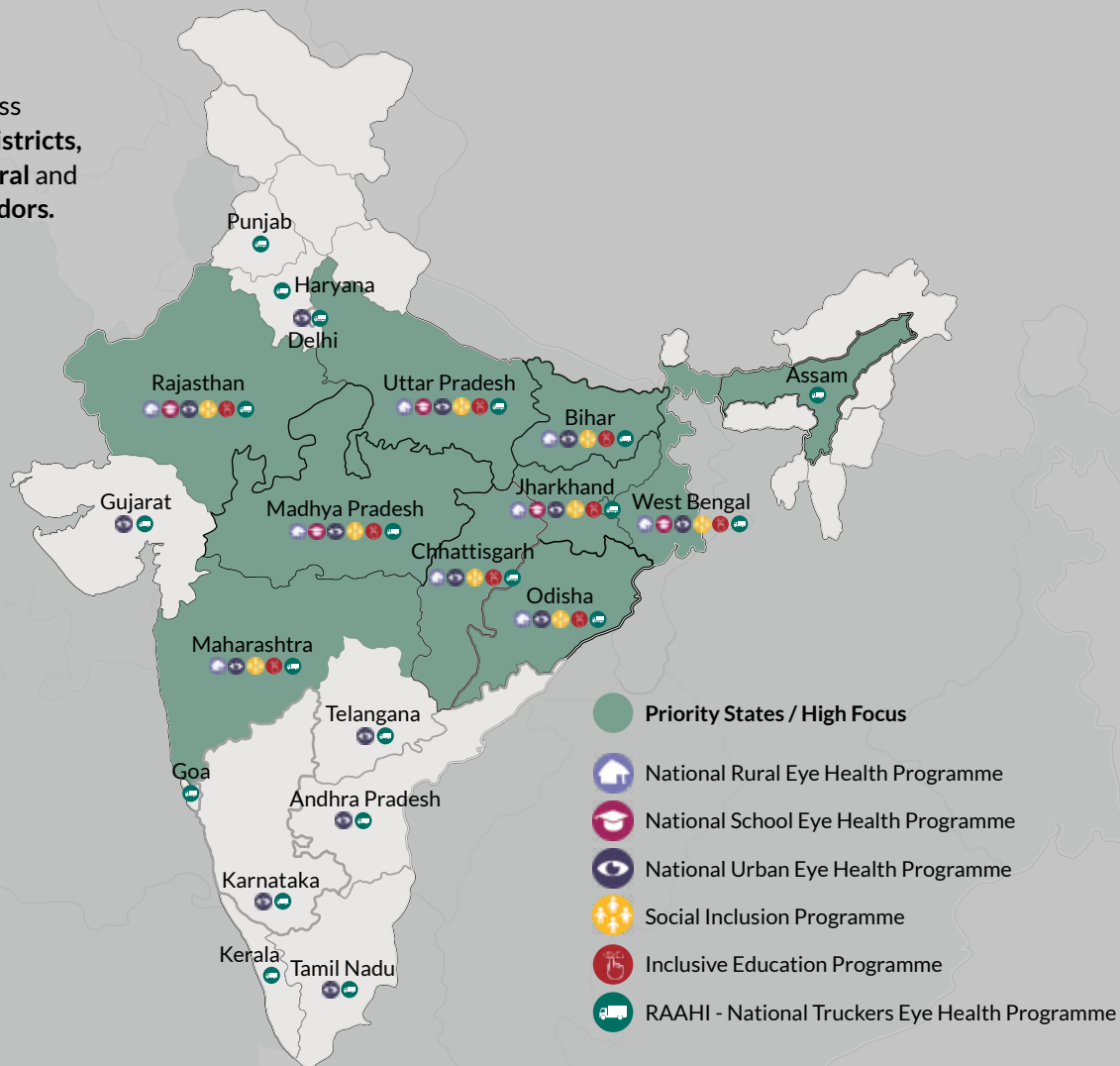

Our journey of 50 years and counting

60s

Sightsavers India started its operations in 1966. Established a robust outreach programme providing mobile eye care vans and equipment support to hospital-based in Tamil Nadu and Uttar Pradesh.

70s

Registered in 1970 and launched the Eyes of India Campaign, which restored sight for more than 400,000 people. Sightsavers India supported setting up the first permanent base hospitals to provide low-cost mass treatment.

80s

Launched our first national programme, The Xerophthalmia Programme to tackle nutritional blindness. Sightsavers India was one of the first eye-care organisations to respond to the 1984 Bhopal Gas tragedy by establishing eye-care hospitals and providing relief supplies.



2000s

Became one of the founding members of Vision 2020 India - The Right to Sight. Scaled up our work to 14 states and pioneered the integrated education IEDC, subsumed in 2009 with Sarva Shiksha Abhiyaan as Inclusive Education.



2010s

We strengthened accessibility with voice-enabled, braille banking services and developed strategic partnerships with State Governments. We were instrumental in making amendments to the India Copyright Act to enable information to be converted into an accessible format.



2020s

Sightsavers India adopted a high-impact district-focused rural eye health model, launched the RAAHI Truckers Programme, Mobile Eye Health Vans, and the Fellowship Programme—ushering in a decade of scalable innovations.

Partnered with various eye care centres to make high-quality cataract surgery affordable, advocated the shift from surgical camps to preventive diagnostic camps, and initiated comprehensive eye care services.

Netra Vasant - The Rural Eye Health Programme

Sightsavers India launched the Netra Vasant - Rural Eye Health Programme, currently operational in **100 districts**, to improve vision-related quality of life by strengthening rural eye health systems in India. With **over 100 static vision centres across ten states**, the programme focuses on reducing blindness, increasing Cataract Surgical Rates (CSR), and ensuring equitable, sustainable eye care for underserved communities.

We aim to achieve universal coverage vis-a-vis eye health services by reducing blindness prevalence, providing equitable coverage, and financial and programmatic sustainability.

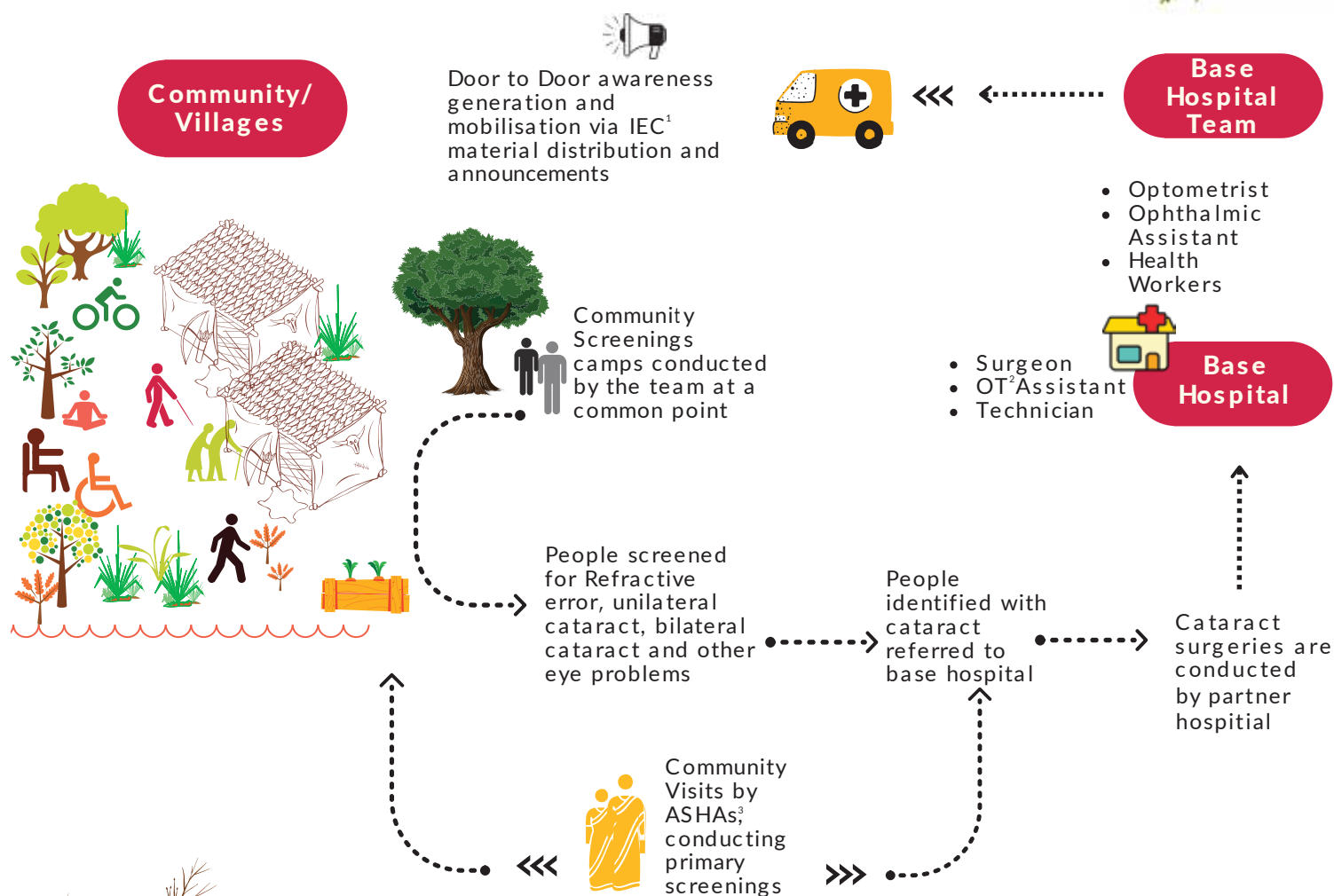

Amrita Drishti - The Urban Eye Health Programme

This programme enables eye care for low-income residents in **17 cities** by integrating its vision centres with Urban Primary Health Centres (UPHCs), establishing partner supported vision centres, building community resources and strengthening the National Health Mission.

It also deploys healthcare **Mobile Vans** offering teleconsultation, glaucoma and diabetic retinopathy screening, portable perimeter, and spectacles. We aim to establish robust primary eye care systems in urban areas lacking essential support.

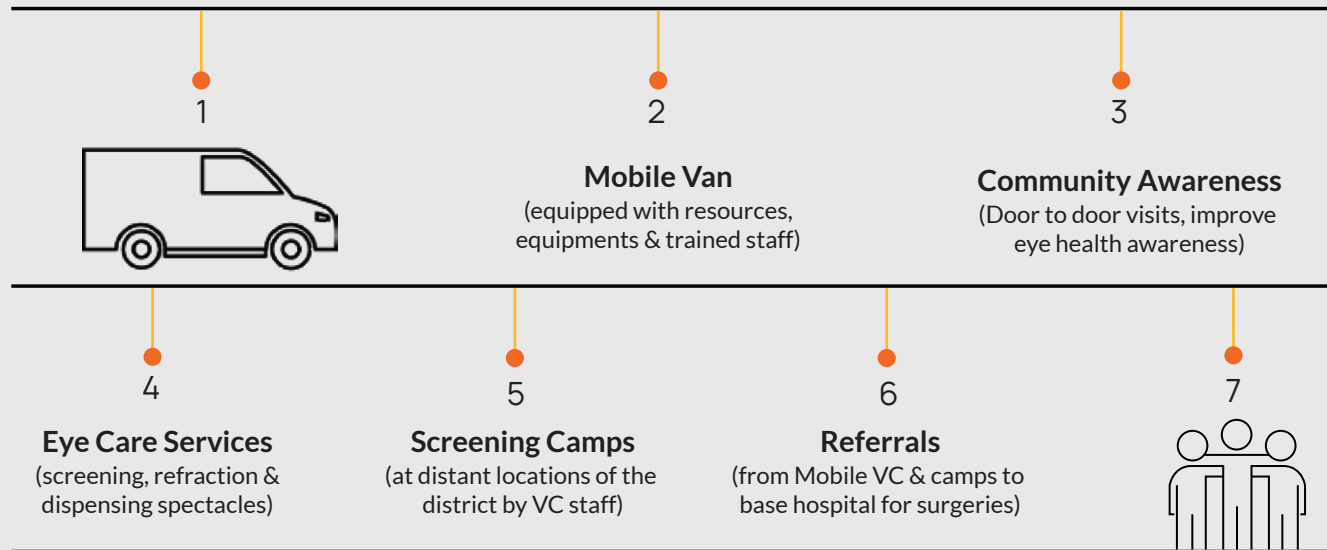

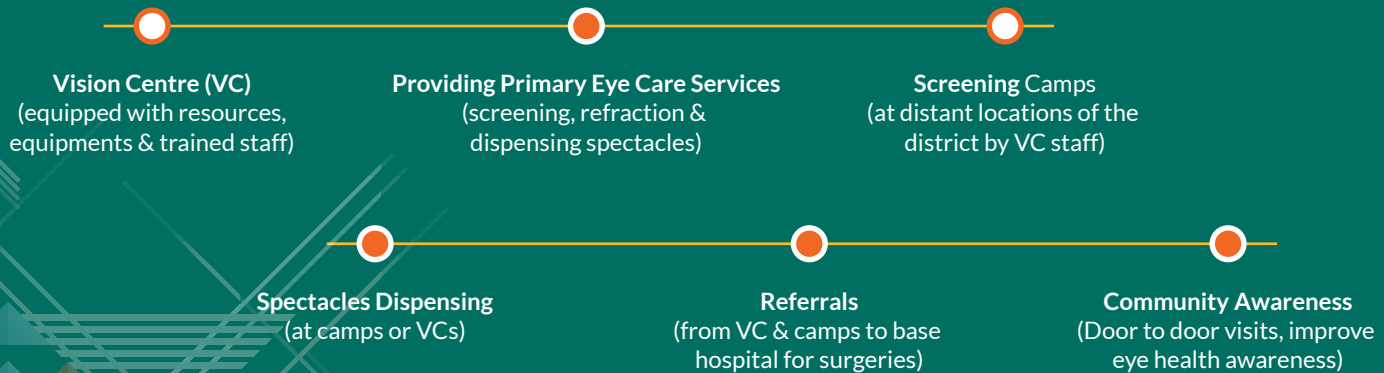

Vidyajyoti - National School Eye Health Programme

This programme is dedicated to enhancing eye health among school children. Currently operational in **5 districts**. Over the past five years, the programme has **screened 4 million students**.

We aim to integrate eye health into broader school health efforts, with key components including teacher training, service delivery, and eye health awareness, to screen, identify, and prevent vision issues from Grades I to XII.

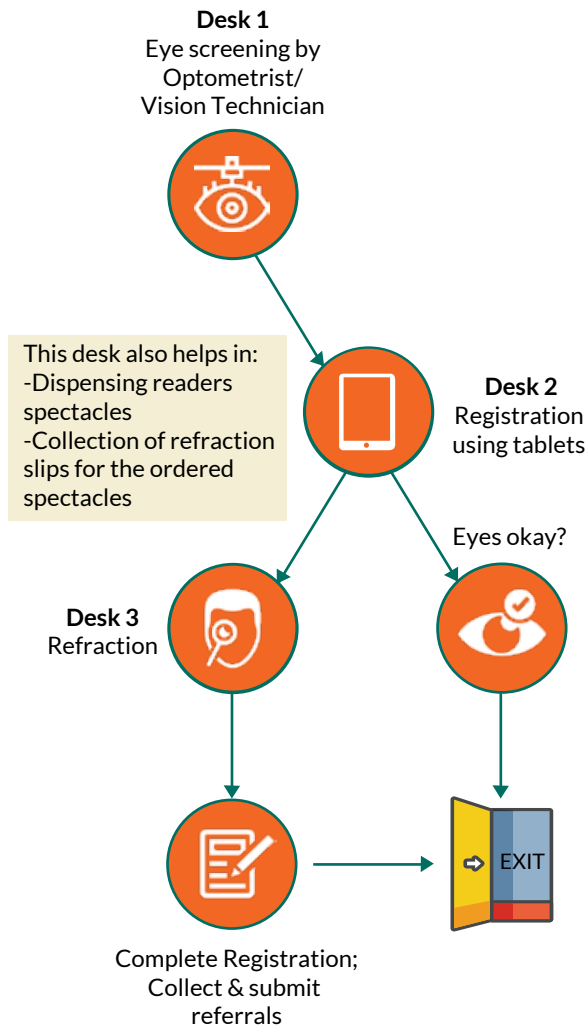

RAAHI - National Truckers Eye Health Programme

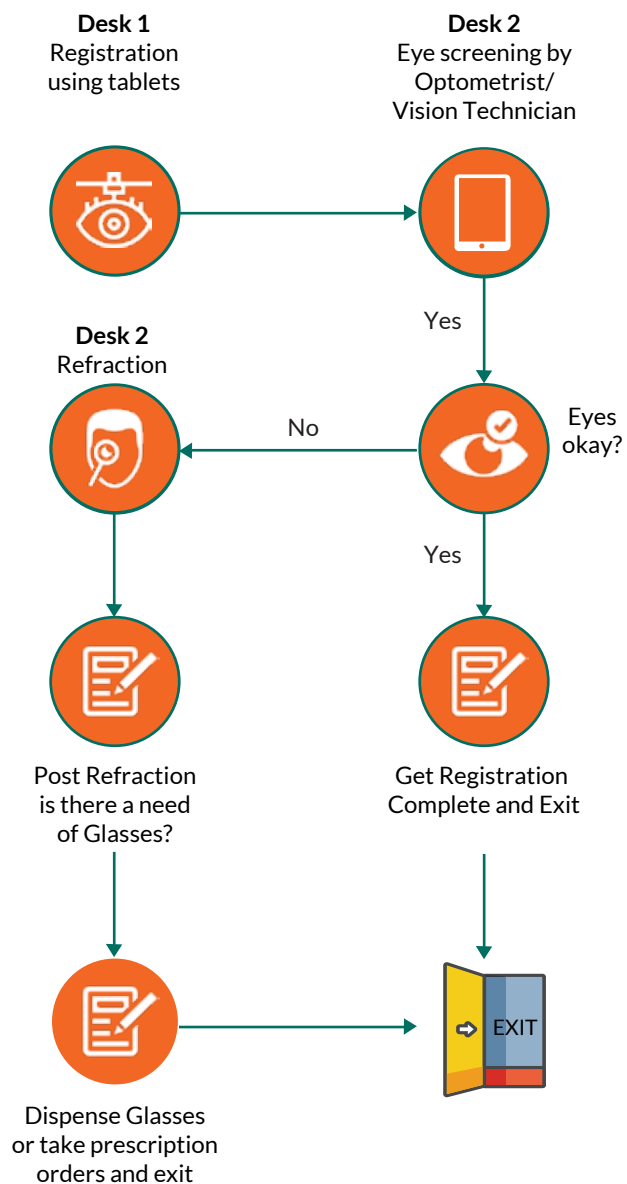
As one of the largest eye health programmes in the country, RAAHI delivers essential eye care services directly to truckers. With presence in **67 locations** along India's major haulage routes, including the **Golden Quadrilateral** and **North-South-East-West (NSEW) Corridor**, the programme features static centres in transport hubs, outreach camps at key locations and mobile vision centres. We also have a cloud-based technology called the **RAAHI App** that enhances the delivery of eyecare services to truckers on the move.

Inclusive Education Programme

Sightsavers India promotes an inclusive environment for children with visual impairments in **13 districts**. It supports **children** by providing assistive devices, accessible materials, and skills training to both teachers and students while ensuring infrastructure accessibility. Focused on children aged 5–18 in government schools under **Samagra Shiksha**, particularly in rural districts, we work closely with families, schools, and communities to ensure every child receives a quality and holistic education.

The Student Tracking Assessment and Reporting (STAR) App tracks the progress of children with visual impairments to strengthen the programme and aims to integrate them into mainstream education and ensure equal opportunities for all.

Social Inclusion Programme

Through this programme, Sightsavers India is committed to empowering people with disabilities by providing essential skills, tools, and support to help them **achieve financial independence** and lead fulfilling lives. With a presence in **12 districts**, the programme has **engaged 2,58,471 people with disabilities (PwDs)** so far. Our Social Inclusion efforts focus on three core areas: Institution Building, Economic Empowerment, and Creating an Enabling Environment. We also adopt a comprehensive gender approach, offering adolescent girls self-defence training and health and hygiene education.



Sightsavers India Fellowship Programme

Sightsavers India is committed to grooming young ophthalmologists into promising and skilled professionals. The Fellowship, an innovative course of mentoring and surgical exposure, is designed to give an opportunity to master the craft of a clinician and a surgeon and expand their perspectives on rural eye health.

Sightsavers India's Fellowship is a promising career opportunity for ophthalmologists. It aims to take selected fellows through an exciting journey of 24 months.

The fellows experience a structured skill enhancement and mentoring process covering not only clinical and surgical ophthalmology but also managerial and holistic life skills. After a rapid four-month training on SICS, the fellows are placed in the peripheral centres of one of the 8 states- Bihar, Madhya Pradesh, Uttar Pradesh, West Bengal, Jharkhand, Rajasthan, Chhattigarh and Odisha. The process involves skills up-gradation components and personal interactions with eminent leaders in the eye care and development sector.

The fellowship also offers opportunities for field exposure through participation in outreach camps, Rapid Assessment of Avoidable Blindness (RAAB) surveys and clinical audits to fellows.





The Government Relations & Policy Engagement (GRAPE) Unit

The Government Relations & Policy Engagement (GRAPE) Unit is responsible for developing sustainable Govt and external stakeholder relationships taking national and state level policy contexts. The unit fosters and develops strategic alliance, partnerships and circles of influence to positively impact evidence-based policy changes and its effective implementation in the areas of eye healthcare, disability inclusive development and inclusive education in India.

GRAPE unit supports Sightsavers Programme Operations in strengthening Govt. partnerships and provide insights to organizational strategy to remain relevant in the changing policy landscape.
